The Board of Supervisors of Upper Mifflin Township met on Tuesday May 9, 2023 at the Township Building, located at 455 Whiskey Run Road, Newville, PA 17241. Kingsley Blasco called the meeting to order at 7:00 pm.

Approval of Minutes: Heidi motioned to approve the April 11, 2023, Meeting Minutes; Kingsley seconded; all were in favor.

Treasurer's Report: Heidi motioned to approve the April 11, 2023, Treasurer's Report, Kingsley seconded; all were in favor.

Visitors: Larry Singer announced that there were 29 total fire calls and none of the were in Upper Mifflin the last month he also stated that the 1st. Saturday Flea Market has begun. Larry had also asked if anyone showed any interest in a bulk clean-up for the Township like North Newton did. Larry provided information to the Township so Valerie could get some information on how North Newton did theirs.
